Language of the Course: English

Short Description:

The seminar focuses on historical methodology, interpretations, and sources for welfare studies. It aims to get the students more familiar with the practical and theoretical aspects of historical research, and how it contributes to political/social sciences approaches. The seminar addresses several aspects: methods of historical research; transnational and global history of welfare state; archival research; critical analysis of the sources.

The first part of the seminar discusses the complementary approaches of historiography and political/social sciences, i.e., periodisation, empirical and qualitative methods, interpretations and theories. The second part dives into the specific tool of historical investigation, i.e., the use of primary sources. Based on the critical analysis of relevant documents, the students will be able to contextualise historically their contents.
